

Registration Contract Fall 2016 – Winter 2017

Tuition / Billing: Tuition is DUE on the 1st class of each month. NO REFUNDS will be given for classes not attended. Tuition stays the same whether there are 3, 4, or 5 weeks in the month. Payments received after the 15th of the month will incur a late fee of \$10. **Please write checks to “Legacy Dance Studio”.** If a check is returned for Non-Sufficient Funds, you will be charged a \$25 NSF fee. Any delinquent accounts after 2 months will be sent to collections. *If a student has not paid tuition by the end of the month, they will not be able to continue attending class the following month until tuition is paid. Students will not be allowed to participate in Recitals or Competitions if their account is not current.*

Collection Accounts: All delinquent accounts will be charged an interest rate of 1.5% per month (18% per annum). In the event any balance is not paid as agreed, the undersigned agrees to pay a collection fee not to exceed 40% of the unpaid balance. In the event a lawsuit is brought against you to collect the unpaid balance, the undersigned further agrees to pay court costs and reasonable attorney fees in addition to the collection fee. The undersigned further authorizes us or our agent to call you at any number you provide or at any number at which we or our agent reasonably believes we can contact you, including calls to mobile, cellular, or similar devices for any lawful purpose. The undersigned also agrees to any fee(s) or charge(s) that may be incurred for incoming calls from us or our agent, and/or outgoing calls to us or our agent, to or from any such number, without reimbursement.

Class Observation: Due to student distraction, we request that parents do not enter into the classroom while class is in session.

Parent Responsibility: Please pick up your child after their class or classes have been completed. Please do not leave your child here any longer than 10 minutes before or after class schedule has started or finished. Thank you.

Missed Classes: No reimbursement of tuition is given for missed classes.

Tardiness: Students need to be to class on time. If a student arrives more than 15 minutes late they will be asked to sit and observe. The beginning of class is the warm up and it is important that students are there to properly warm up to avoid any muscle injuries.

Costumes: Parents will be asked to provide some articles of clothing for their child’s costume such as tights, leotard, etc. The rest of the costume will be rented to the student (dresses, skirts, hair pieces, etc.). These items will not be kept by the students; they must be returned to the instructor at the end of the final performance. Students will be given the option to purchase their costume if they desire. The recital / costume fee will be adjusted based on the cost of the costume. You will need to discuss this with the Director if you wish to purchase instead of rent your costume.

Recital & Costume Rental Fees:

****Competing team members: \$45 recital fee per semester**

****Non-competing team members: \$30 recital fee per semester**

****Costume rental \$15 per class**

****FAMILY DISCOUNT:**

1st child: \$30 recital fee (non-competing), \$45 recital fee (competing)

2nd child: \$15 recital fee (non-competing), \$30 recital fee (competing)

3rd child +: no recital fee, \$15 costume rental

****Musical Theatre: \$50 Production Fee**

****No fees due for technique classes or tumbling classes**

****Please note these fees are NON-REFUNDABLE****

Tickets for the Dance Recital will be \$5.00 a person. Tickets are non-refundable. Dancers will not need to purchase a ticket. Children 3 and younger do not need to purchase a ticket (lap child). If child requires a seat then a ticket will be required to purchase.

Risk: I recognize the potential for injuries, including permanent paralysis or death that can occur in activities involving height or motion, including dance. Being fully aware of these dangers, I voluntarily consent the below mentioned person to participate in any and all Legacy Dance Studio programs, rehearsals and activities and I ACCEPT ALL RISKS associated with that participation. In consideration for allowing my child(ren) to use these facilities, I, on my own behalf and the behalf of my child(ren) and our respective heirs, administrators, executors and successors, hereby COVENENT NOT TO SUE and FOREVER RELEASE Legacy Dance Studio without limitation, those damages or injuries resulting from acts of negligence on the part of its officers, directors, shareholders, employees or agents. In the event of an accident or emergency I would like my below mentioned child(ren) to be taken to a hospital for medical treatment and I hold Legacy Dance Studio and the and its representatives harmless in their execution of this matter. Additionally, I hereby agree to individually provide for all possible future medical expenses which may be incurred by my child(ren) as a result of any injury sustained while participating at or for Legacy Dance Studio.
